In addition, as of March 31, 2010, the Company had 238 cash advance storefront locations operating in six states in the United States under the names "Cash America Payday Advance" and "Cashland" and 119 unconsolidated franchised and five Company-owned check cashing centers operating in 16 states in the United States under the name "Mr. Payroll."
