

**CASH AMERICA, CASHLAND, SUPERPAWN  
“MyStartingPoint” REWARDS PROGRAM SWEEPSTAKES  
APRIL – FINANCIAL LITERACY MONTH  
OFFICIAL RULES**

**1. ELIGIBILITY: NO PURCHASE NECESSARY.** The “MyStartingPoint” (A CFEF- Community Financial Education Foundation Program) Rewards Program Sweepstakes (“Rewards Program”) is open to residents of the 50 United States and the District of Columbia, 18 years of age or older at time of registering (“registrant”, “entrant”, “you”, “your”). Employees and agents of Cash America International, Inc. (“Sponsor”), and its present and future direct and indirect parents, affiliates, successors, partners, subsidiaries, officers, employees, directors, agents, licensors, licensees, distributors, retailers, advertising and promotion agencies (“Sponsor Affiliates”), and their immediate families or household members of each are not eligible to participate. By creating an account on Cashland’s MyStartingPoint Program website, you are agreeing to be automatically registered with the Rewards Program. Registration began on July 1, 2013. To enter the Rewards Program Sweepstakes, you must go to Cashland’s “MyStartingPoint” Program (the “Program”) website at: <https://cashland.mystartingpoint.org> and sign up to create an account with the Program and complete the specific “Badge of the Month.”

3) Go to the Super Pawn website at: <https://superpawn.mystartingpoint.org> and sign up to create an account. By creating an account on Super Pawn’s MyStartingPoint Program website, you are agreeing to be automatically registered with the Rewards Program. Registration began on July 1, 2013. To enter the Rewards Program Sweepstakes, you must go to SuperPawn’s “MyStartingPoint” Program (the “Program”) website at: <https://superpawn.mystartingpoint.org> and sign up to create an account with the Program and complete the specific “Badge of the Month.”

**3. APRIL REWARDS:** Those participants who register for the Cash America, Cashland or SuperPawn “MyStartingPoint” Program (only one (1) entry method allowed) and complete the specific “**Badge of the Month**” as indicated on the Rewards Program, are agreeing to be automatically entered into April’s pool for the weekly random drawings to be held on the following days: Friday, April 8, 2016; Friday, April 15, 2016; Friday, April 22, 2016; and Monday, May 2, 2016. The reward is one (1) \$250 Visa® gift card per brand, per week, for a total of twelve (12) Visa® gift card rewards. There will be four (4) random winners chosen from each of the three (3) methods of entry listed in Section 2 above. The combined total reward amount is \$3,000.00.
